PARADE LAWS AND REGULATIONS

The Elgin Police Department will enforce all state and municipal traffic laws during this event and parade. This will include Section 542.420 which prohibits the demonstration of vehicle speed or display or acceleration (burning) and Section 547.604 which states that vehicles must be equipped with a muffler in good working condition that operates continuously to avoid excessive or unusual noise and avoid the use of cuts, shunts or similar devices in a motor vehicle. Due to safety considerations, not all vehicles in the parade will be allowed to swerve, turn or enter and exit traffic during this event, offenders will be removed from the parade. Your help in maintaining a safe and healthy environment will make this an enjoyable event for everyone.

2022 Elgin Lighted Christmas Parade **Information and Rules**

1. ALL PARTICIPANTS MUST REGISTER AT THE REGISTRATION TABLE NO LATER THAN 4:30PM. Collect their numbers and map by 4:30 PM. at the Elgin Memorial Park enter at Park & Ride Elgin Recreation Center Parking Lot 361 SH-95 Elgin Texas 78621).
2. The parade evaluation will begin at 6:00 PM. Floats must be in place and participants must be present to be eligible and evaluated. If you do not wish to be judged, you must still be in place and ready to depart no later than 5:30 PM. Categories to be judged are included in the Parade Registration Form (Page 1)..
3. **THE PARADE WILL BEGIN AT 6:00 PM**
4. **ALL ENTRIES MUST BE LIGHTED – must use LIGHTS and must be VISIBLE – SAFETY is TOP PRIORITY**
5. A licensed driver must drive cars, tractors, and large vehicles. Drivers are responsible for the safety and behavior of their participants. Small vehicles (minibikes, small tractors, etc.) must be driven by a person over the age of 12 and parents will be responsible for their conduct.
6. Bring water / bottled water for your participants. **ABSOLUTELY NO ALCOHOLIC BEVERAGES MAY BE CONSUMED BEFORE OR DURING THE PARADE.**
7. All vehicles participating in the parade must be clean and in safe operating condition. They must also be operated on safely so as not to endanger other participants or spectators. The entire safety team is the responsibility of the participant.
8. An adult supervisor who will be responsible for the behaviour of its participants shall represent each group of young people. Adult groups must appoint a contact person. The names of the supervisor or contact person must be submitted at the time of registration including cell numbers.
9. Equestrian units are welcome. All horses in the parade must have current Coggins records. Submit this with registration. All equestrian units must provide their own "cleaning equipment" for their unit.
10. Each entry, other than horses, tractors or antique cars, must be a decorated float or a vehicle representing an organization, festival or company.
11. For safety reasons, **NO ITEM, INCLUDING BUT NOT LIMITED TO MERCHANDISE, TOYS, CANDIES, FLYERS, ETC. CAN BE THROWN, HAND OR PASSED FROM ANY FLOAT, VEHICLE OR PARADE ENTRY.**
Walkers can hand out material as long as it is not a distraction and is done on the edge of the parade route next to the spectators and these people MUST WEAR LIGHTS and BE VISIBLE. Children run to vehicles passing items and for the safety of children attending the parade **THERE ARE NO EXCEPTIONS TO THIS RULE.** Violators will be immediately removed from the parade.
12. Due to the length of the parade, it is very important that you keep moving. Please do not intentionally stop or slow down the parade for any demonstrations, etc. If your vehicle has mechanical or other problems, step aside and we will try to provide assistance.
13. As a courtesy to the other participants of the parade, do not dissolve until you reach the end.
14. Exceptions to these rules can only be made with the approval of the Elgin Lighted Christmas Parade Committee.
15. The Parade Committee reserves the right to refuse entry to any float, unit or individual. Failure to comply with the parade rules may result in the elimination from the parade formation and will affect future invitations.
16. The City of Elgin, Elgin Volunteer Fire Department and Bastrop Travis Counties ESD #1 assume no responsibility for participant behavior, accidents, injuries, damages or losses of any kind. Participation is at your own RISK and is VOLUNTARY.
